Introduction

Welcome to PFASGlobalView developed by Ramboll. It is a system designed to easily make PowerBI Dashboards available for set amount of time to a specific set of individuals.

In order to make the platform available, your personal data is processed in connection with user registration and your use of the platform. We are committed to protecting your personal data and ensuring your privacy. This privacy notice details how we collect and use your personal data when you create a user in PFASGlobalView.

Our role in processing personal data

Ramboll is the data controller for the user data connected to your user profile in the system. We determine the purposes and means of processing your personal data, for example, when you interact directly with our system for account creation, customer support, or other activities related to the management and maintenance of the system. In other words, the processing of your personal data is to

- manage and maintain your account
- provide customer support and respond to your inquiries
- improve and enhance the functionality and user experience of the system
- maintain the system and perform the necessary backup and recovery actions

Our purpose for processing your personal data is to be able to deliver a service to our customers, and for product development and improvement purposes. We process personal data for user research purposes to understand and improve how users interact with the platform.

Types of personal data we process

We process the following user information:

- Name
- E-mail address
- IP-addresses

Legal basis for our processing of your personal data

Legal basis: The legal basis for the processing of your personal data follows the General Data Protection Regulation (GDPR) article 6(1)(f).

Legitimate interest: The processing of personal data takes place to deliver secure access to and maintain and develop the system.

Disclosure of your personal data

We make personal data available to our IT suppliers, incl. IT service and consultancy providers, that store and process personal data on our behalf for the purpose of providing functionalities such as notification through e-mail, hosting and maintaining the solution's infrastructure. Such suppliers are subject to our instructions regarding the storing and processing of personal data. Some data processors or sub-processors may be located outside of the EU. The transfer of personal data is based on the EU Commission's Standard Contractual Clauses or the EU-US Data Privacy Framework.

Data retention

Ramboll retains your personal data for as long as necessary to fulfill the purposes for which it was collected, and after 12 months of inactivity in the system.

Your rights

In accordance with the GDPR, you have several rights in relation to our processing of your personal data:

- Right to access: You have the right to access the information we process about you, as well as a number of additional information.
- Right to rectification: You have the right to have incorrect information about yourself corrected.
- Right to erasure: In special cases, you have the right to have information about you deleted before the time of our general deletion occurs.

- Right to restriction of processing: In certain cases, you have the right to have the processing of your personal data restricted.
- Right to object: In certain cases, you have the right to object to our or lawful processing of your personal data.
- Right to data portability: In certain cases, you have the right to receive your personal data in a structured, commonly used and machine-readable format and to have this personal data transferred from one data controller to another without hindrance.
